Interest Rates: Debts Owed to the State and Refunds Due by the Minister

This bulletin gives the interest rates for the first quarter of 2025 applicable to debts owed to the State and to refunds due by the Minister of Revenue under a fiscal law. It also states the rules in effect for the determination of such interest rates.

Interest rates for the period from April 1, to June 30, 2025 (Avis, (2025) 11 G.O.Q. I, page 171)	
Debts owed to the State	8.00%
Refunds due by the Minister	3.50%

Under section 28 of the *Tax Administration Act* (hereinafter the “TAA”), a debt owed to the State by any person under a fiscal law bears interest. Any refund due by the Minister of Revenue under such a law also bears interest. In both cases, interest is capitalized daily.

Under sections 28R1 and 28R2 of the *Regulation respecting fiscal administration* (hereinafter the “Regulation”), the interest rate applicable to debts owed to the State is determined, for each quarter of the calendar year, according to the mean of the base rate for bank loans made to businesses as published by the Bank of Canada on the last Wednesday of each of the months included in the three-month period ending in the second month of the preceding quarter. The result is rounded off to the nearest whole number, one-half being rounded off to the lower whole number. Also, 3% is added to the rounded-off result.

As for the interest rate applicable to refunds due by the Minister, the second paragraph of section 28 of the TAA provides that, for each quarter of a calendar year, such rate corresponds to the interest rate in effect on the first day of the third month of the previous quarter in relation to the latest issue of Québec savings bonds.

Finally, the interest rate for a quarter applicable to debts owed to the State and the interest rate for a quarter applicable to refunds due by the Minister are published in the *Gazette officielle du Québec*.

The history of the interest rates applicable since December 13, 1972, is set out in the Appendix.

APPENDIX

HISTORY OF INTEREST RATES

The table below gives the interest rates applicable since December 13, 1972 (in reverse chronological order).

NOTE: For the periods from October 1, to December 31, 1990, from January 1, to March 31, 1991, and from April 1, to June 30, 1991, the interest rate applicable to refunds to corporations was determined according to the rules provided for in section 28R2 of the Regulation, except for the increase of 2%.
